ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Yakima Valley Libraries from January 1, 2010 through December 31, 2011.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Open Public Meetings Act
- Foundations/Friends of the Library
 - authority
- Cash-receipting
- Bid compliance
- Disbursements
- Travel/credit card use
- General obligation debt – use of debt proceeds

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE DISTRICT

The Yakima Valley Regional Library was established in 1951 to provide library services throughout Yakima County. It is now the Yakima County Rural Library District, doing business as Yakima Valley Libraries. The District is governed by a five-member Board of Trustees, appointed by the Yakima County Commissioners. The Yakima County Treasurer is the treasurer ex-officio for the District. The majority of the approximately \$6 million in annual revenue comes from property tax assessments. The District operates 18 branches with approximately 103 full and part-time employees.
